**4.** The Tender shall remain valid for a period of One Hundred Eighty (180) days from the date of opening or till any extended period.

**5.** Eligibility Criteria:

**5.1 Permit**: The Tenderer should have valid permit/registration from a competent local authority for carrying out the work in **Lagos (Nigeria)** in the Diplomatic property of the **Office of the High Commission of India, Lagos (Nigeria)**.

**5.2 Similar work**: The Tenderer must have satisfactorily completed (i) one similar work of value of atleast Naira 174 million (ii) two similar works of value of atleast Naira 130 million (iii) three similar works of value of Naira 87 million. Similar works means Renovation in the office spaces/buildings (preferably Diplomatic Missions), Roof Repairs/Waterproofing and Other Minor Works (Security perimeter, painting, electricals/ plumbing repairs, lighting, etc.) (iv) Copies of Letter of Award of Work indicating cost of project and copies of completion certificates to be submitted in support.

**5.3 Bank Solvency**: Certificate of Solvency for Naira 87 million certified by bank. The certificate should not be older than six months.

**5.4 Annual Turnover**: The annual turnover of the tenderer should be equal to atleast Naira 217 million during the immediate last three consecutive financial years. This should be duly audited/certified by a Chartered Accountant. Year in which no turnover is shown would also be considered for working out the average.

**5.5 Profit-Loss**: The tenderer should not have suffered loss in more than two years in the previous five financial years and must not have suffered loss in the immediate preceding financial year. This should be duly audited/certified by a Chartered Accountant.

**6. Defects Liability Period**: Defects Liability period will be twelve months from date of completion of project.

**7. Performance Security**: 5% of the contract value shall be submitted in the form of a Bank Guarantee valid for a period of sixty days beyond the date of the completion of all the contractual obligations of the supplier under the contract and discharged after completion of work (Format of Performance Security is attached).

**8. Financial quote & variations**: Contractor shall quote his Lump-sum Fixed Price based on the enclosed Scope of Work. The Contractor shall note that Bill of Quantities (BOQ) shall not form part of the agreement and Contractor shall complete all the works as defined in the Scope of Work irrespective of the Bill of Quantities (BOQ)/details since these will not form part of the agreement. **9. Commencement**: Commencement of the works shall be effected within Fifteen (15) days from the date of issue of Acceptance letter or Letter of Intent or handing over the site, whichever is later. Such 15 days period being defined as the mobilization period.

**10. Completion**: The Period of Completion for the whole of the works is Two hundred seventy (270) days calculated from the date of commencement of works.

**11.** Extension of time (EOT): EOT will be granted by *Project Management Consultant* (*PMC*) based on a hindrance report submitted by the Contractor. Hindrance, if any, must be reported to the PMC within seven (7) days of occurrence. PMC may/may not agree to the grant of EOT. The Engineer In-charge shall grant EOT after approval of the Employer.

**12. Retention Money**: 5% of the accepted contract value to be deducted from the running bills. 50% retention money will be released after 60 days of certified completion of the project and remaining 50% to be released after completion of the defect liability period.

# **13.** Arbitration:

- **13.1** If any dispute, difference or question at any time arises between the Mission and the Contractor in respect of the agreement signed which cannot be settled mutually or in case of termination, shall be referred to arbitration.
- **13.2** The arbitration proceedings will be conducted in accordance with and be subject to the UNCITRAL (United Nations Commission on International Trade Laws) Arbitration Rules, as amended from time to time and the decision of the arbitrators as mentioned above shall be final and binding on the parties.
- **13.3** The Arbitration will have its sittings in Office of the High Commission of India in Lagos (Nigeria).

**14. Rejection**: Office of the High Commission of India reserves the right to accept or reject proof of credentials at its sole discretion without having to furnish reasons thereof, to the applicants. Submission of false information/document shall render the bidder ineligible.

**15. Sub-contractors**: The Tenderer must submit with his offer a list of names of Sub-Contractors and Specialists he proposes to use on the Works. # 1.8 Tender and Schedule of Quantities
